## **PREFERENCES**

- Restriction of state and municipal control
- ✓ Zero import and export customs duties
- Engaging foreign labour without taking quotas into account
- Reduced rates for rental payments
- Residents of priority development areas (PDAs) are entitled to connect to infrastructure facilities: light, water, gas, water discharge and heat supply
- PDA residents may obtain a land plot without a bidding process





REQUIREMENTS -

for a person claiming the status of a Resident


- PDAs 0 5% (for 5 years), for the subsequent 5 years 12%; FPV 0% (for 5 years), for the subsequent 5 years 12%
- <sup>2</sup> PDAs 0% 1.5% (for 3-5 years); FPV 0% (for 3 years)
- <sup>3</sup> PDAs 0% 0.3% for 5 years, for the subsequent 5 years 0.5-2.2%; FPV 0% (for 5 years), for the subsequent 5 years not more than 0.5%
- \*except for the production of passenger cars, motorcycles, engine oils, aircraft fuel, diesel and motor car fuel

-The activity of parking lots for transportation vehicles.

\*\* except for the rental and leasing of agricultural equipment; construction machines and equipment for public works and transportation vehicles; air, water and rail transportation vehicles; engines, turbines and machine tools; other machines, equipment and material resources; the activity of travel agencies and other organisations providing services in the travel sector
