





• Provided integrated legal support to a client in the context of a complicated project connected with the bad-faith registration of a medicine by a Russian pharmaceutical company. Our efforts enabled registration of the medicine in the name of our client.

• Tackled a number of complicated regulatory matters while providing legal support during the launch of an innovative medical product on the Russian market. Provided support during a transaction under which a foreign company purchased one of the largest Russian pharmaceutical companies. Within the project we conducted a regulatory check of the portfolio of medicines, then devised financing mechanisms and structured the transaction.

Provided legal support in the day-to-day operations of two biotech start-ups. The tasks completed included the following: ensuring that all agreed corporate governance procedures were implemented properly; devising a number of internal documents of the company; and advising on the import of chemical agents, pre-clinical and clinical trials, the transfer of foreign technologies, the obtaining of grants as well as on complex budgetary and legal aspects of performing and terminating state contracts.

· Provided support to one of the world's largest pharmaceutical companies performing clinical trials in Russia: devised legal recommendations for patients to participate in them as well as mechanisms of conducting clinical studies in relation to a medicine the use of which is closely related to a specific medical product.

• Advised one of the world's ten largest pharmaceutical companies on a broad spectrum of issues concerning its current activities: interaction with distributors, amending the commercial policy, important aspects of the circulation of orphan medicines as well as legal nuances of the circulation of medicines in the markets of some former USSR countries.

As a result, our lawyers successfully drew on their knowledge of the main antitrust risks and ways of preventing them when providing support during a range of audits conducted by the Russian Federal Antimonopoly Service in relation to pharmaceutical companies, and, subsequently, during litigation involving the regulator's decisions being contested.

Advised a client in relation to the tax implications and risks pertaining to a contract for the manufacturing and sale of a medicine within a group of affiliated companies, taking into account the actual distribution of functions and pharmaceutical licences. Based on the results of this work, we proposed an option for structuring the relationships with the minimum of tax risks, which did not violate the requirements of legislation on the circulation of medicines.
