REGULATORY DEVELOPMENTS

The tax regime will remain unchanged until 2019, the Russian President has said. The oil and gas sector will be an exception.

Russia has postponed the ratification of the Paris Agreement at least until 2020.

The use of the automated control system ACS VAT has decreased by nine times the number of claims filed by companies with a high risk level seeking VAT refunds, and over 9,000 taxpayers have updated their tax returns.

The fact that the law relating to the 'tax on Google' does not provide for liability to be imposed on international organisations for failure to comply with the law will not become a problem, believes Mikhail Bykovsky, Deputy Director of the Regulation Department for Radio-Frequencies and Communications Networks at the Russian Ministry of Communications and Mass Media: 'Such a foreign organisation could probably just be disconnected from the Russian part of the Internet'.

In the Interos LLC case the Russian Supreme Court has agreed with the tax inspectorate: if a new company continues with the business of its predecessor, it must pay off its predecessor's debts, even if the new company receives revenue for new goods and services.

On September 28 the IP Court returned for review the case of the American company Dell relating to the claim filed by the Russian Union of Rightholders for Dell to pay RUB 79.7 million as remuneration for the free reproduction of phonograms and audiovisual works for personal purposes. According to the company, it has managed to prove that to recover 1%, it is required not only that the goods be classified in accordance with the codes under the Commodity Classification for Foreign Trade, but also that all of the equipment's design specifics and consumer features be carefully analysed.
