REGULATORY DEVELOPMENTS

The Russian President has signed the laws to ratify:

- the protocol to the Agreement between Russia and Singapore for the avoidance of double taxation and the prevention of fiscal evasion with respect to taxes on income and capital;
- the Agreement between Russia and Hong Kong (China) for the avoidance of double taxation and the prevention of fiscal evasion with respect to taxes on income and capital.

In addition, a set of laws has been signed that authorises the tax authorities to administer insurance contributions for compulsory pension, health and social insurance. Further, a law has been signed to improve the taxation system for owners of trucks with a maximum laden weight exceeding 12 tons.

The Russian Government has distributed powers between ministries and state agencies with regard to apostilles on Russian documents that need to be taken out of Russia. Tax and other documents relating to business are apostilled by the Russian Ministry of Justice.

The Federation Council has approved a number of tax laws, including:

- "On amending the Federal Law "On currency regulation and currency control" which changes which bodies and agencies perform currency control;
- "On state cadastral valuation", which creates a new state monopoly;
- "the law on the Google tax" which provides for VAT to be charged in relation to online operations when foreign companies are selling electronic services to Russians;
- on the transition to new cash register equipment;
- on partially decriminalising economic crimes, including tax crimes.

The Russian Constitutional Court has decided that charging heavy trucks for journeys on federal highways by means of the Platon system is not in violation of long-distance truck drivers' rights. The court specified that "the charges that are determined should not be too high and too onerous for the drivers".

The presence of a 'parallel tax system' in the form of public fees does not contradict the Russian Constitution, but requires additional legitimation, says Russian Constitutional Court judge *Gadis Gadgiev*, who partially disagrees with the reasoning of the decision of the Russian Constitutional Court.
