

Clinical research and trials

- Advising on the implementation of the results of clinical trials that were obtained abroad for registration in Russia and the EAEU; legal nuances of their cross-border transfer, ethical aspects of research and other issues
- Providing legal assistance with the conclusion of contracts with medical institutions and organisations involved in clinical trials (CROs)

Localising manufacturing

Legal support with regard to other aspects

 - In the context of registering a medicine, medical devices, food supplements and cosmetics, including when (re)registering the maximum selling prices of medicines included in the List of Vital and Essential Medicines;
 - In the context of devising a strategy for launching a medicine/medical device on the Russian/EAEU market, including in relation to issues connected with patent protection and the exclusivity of data pertaining to the medicine;
 - In connection with participation in state procurement procedures (including with regard to issues of entering into contracts using lifecycle-contract models and long-term contracts)
- Providing legal support during inspections by supervisory authorities, as well as when such authorities' actions and decisions based on the results of such inspections are subsequently challenged
- Providing legal support to pharmaceutical and medical technology companies regarding customs, tax and currency issues connected with their activities

Selected projects

Assessed and mitigated risks arising during an advertising campaign

For the purposes of assessing and minimising the client's potential risks arising during an advertising campaign which included putting into circulation batches of goods with changed packaging (labels) and placing advertising materials in retail chains and on the Internet, the client had requested us to prepare a legal opinion on the materials of the advertising campaign and to provide practical recommendations as to how the identified risks could be mitigated.

Clinical trials in Russia

Provided legal support to one of the world's largest pharmaceutical companies performing clinical trials in Russia: we devised legal recommendations for patients to participate in the trials as well as mechanisms of conducting clinical studies in relation to a medicine the use of which closely relates to a medical product.

Provided comprehensive support to the client during the change of the distribution model

The client was considering changing the form of its presence in Russia including changing how medicines were to be supplied to Russia. In this regard, the client needed comprehensive legal support during the process of changing the distribution channel. In particular, we needed to assess different options for restructuring contractual and corporate relationships from the standpoint of the legal and transactional risks, to prepare a commercial policy that would be in line with the client's interests and be compliant with Russian legislation, relevant case law and business practice, to draft intra-group agreements (for the supply of medicines, for registration services and an agency agreement) and to prepare a template of a supply agreement with Russian distributors.

Selected projects

Prepared overviews of counter-sanctions for pharmaceutical companies


Prepared daily, weekly and monthly reviews of counter-sanctions and support measures with a brief description of each amendment, its status and potential effect on business, as well as how it is connected with other laws. In addition to regulatory and legal acts, the review included relevant judicial cases demonstrating how courts and administrative bodies were applying counter-sanctions and support measures, as well as certain non-regulatory legal acts, clarifications, letters and guidelines by authorised bodies.

Provided legal support to a major pharmaceutical company in its day-to-day operations

In the framework of legal support of the client's day-to-day operations we were preparing legal opinions and drafting contractual documents in different areas including employment law and currency regulation, as well as regulatory (such as conducting clinical trials) and commercial matters (including adjusting commercial policies and considering specific situations in which they were applied).

Expanding geographical coverage

In order to identify the most effective model of business coverage in Kazakhstan for a major Russian pharmaceutical company, it was necessary to consider different options for forming the marketing function in Kazakhstan, taking into account local risks, as well as the regulatory, commercial, tax and employment risks of the parent company, which is a resident of Russia.



Localisation of the manufacturing of vital and essential medicines in Russia

Provided legal support in a project involving the localisation in Russia of the manufacturing of a medicine which is on the List of Vital and Essential Medicines, which included preparing an opinion regarding the legal and tax risks connected with different contractual models, analysing agreements for the purchase of rights to a product, developing a template agreement for contract manufacturing (including all necessary appendices) and providing additional advice regarding the use of the agreement when a specific transaction is formalised.

Tax support

Provided tax support for a medicine of Russian origin to be launched on international markets, including with regard to its export out of Russia, manufacturing abroad to be subsequently sold on foreign markets, or licences being granted to foreign manufacturers.

The manufacturing and sale of a medicine

Advised the client regarding the tax consequences and risks arising from the terms and conditions of an agreement for the production and sale of a medicine within a group of affiliated companies, taking into account the actual distribution of functions and pharmaceutical licences. Based on the results of this work, we proposed an option for structuring the relationships with the minimum of tax risks, which did not violate the requirements of legislation on the circulation of medicines.

Contract manufacturing of active pharmaceutical ingredients and biological substances

Pepeliaev Group's lawyers have provided legal support to a client within the framework of organising the contract manufacturing of active pharmaceutical ingredients and biological substances jointly with a Russian pharmaceutical company.

Antitrust audits


The experts of our antitrust practice have conducted a considerable number of antitrust audits in relation to the activities of pharmaceutical companies, thus accumulating a wealth of knowledge concerning the specifics of business in this industry in the Russian market. As a result, our lawyers successfully implement their knowledge of the main antitrust risks and ways to prevent them when providing support during a range of audits conducted by the Russian Federal Antimonopoly Service in relation to pharmaceutical companies, and, subsequently, when the regulator's decisions are contested in courts.

Investing in the production and acquisition of new assets

Pepeliaev Group's services also encompass legal support for Russian and global companies in relation to the legal aspects of business development, namely, investing in the production and acquisition of new assets (including rights to medicines). For instance, our lawyers have assisted a major investment fund and one of its portfolio companies, a Russian manufacturer of medicines that was acquiring rights to several brands of premium generic medicines for subsequent in-house manufacturing.

Transfer and use of patients' data

Drafted a legal opinion on whether patients' data can be transferred and used for researching routine clinical practice. Within the framework of the project we analysed the relevant legislation, court and administrative decisions, positions of state authorities, the trends in the legal regulation, and provided an assessment of data being transferred (personal or depersonalised, or anonymous and aggregated data). We prepared a position on whether the transfer of data was lawful and assessed the corresponding risks.
