REGULATORY DEVELOPMENTS

At the beginning of July the Russian President signed a number of tax laws:

- on the ratification of the Agreement between Russia and Hong Kong (China) for the avoidance of double taxation and the prevention of fiscal evasion with respect to taxes on income and capital

- on the transfer to tax authorities of powers to administer insurance contributions from extra-budgetary funds, on 1 January 2017.

- amendments to the Law on cash register equipment: in one year cash registers in Russia should have access to the Internet, and in two years all entrepreneurs will be obliged to create online receipts

- on partially decriminalising economic crimes, including tax crimes

- starting from 1 January 2017 foreign companies will have to pay a tax on online sales of electronic software and content in Russia

The Russian Federal Tax Service organises meetings with representatives of internet industry and of major auditor and law firms, during which the new Law is discussed. A test version is provided of an electronic service for the registration of foreign internet companies.

In the wake of the idea being expressed to lower the threshold for duty-free cross-border online sales, the Russian Federal Tax Service, together with other relevant agencies, is preparing a proposal to introduce VAT for foreign online trading platforms.

The Russian Federal Tax Service is proposing amendments to the List of states and territories that do not cooperate in the area of exchanging tax information. These include: Cayman Islands, Bermuda, Mauritius, Aruba, as well as Hong Kong, Estonia and Georgia.

When tax authorities audit businesses together with the police, the average amount of additional tax assessments rises sharply: researchers of the Financial University under the Russian Government have discovered that when tax authorities act independently, they reassess upwards RUB 7.5 million per audit on average, and when the police are involved, this amount doubles or triples.

Before 1 July 2017 information that has ceased to be a tax secret should be published on the Russian Federal Tax Service's website. The development is provided for by Federal Law No. 134-FZ dated 1 May 2016.
