REGULATORY DEVELOPMENTS

On 2 June, the State Duma (the lower chamber of the Russian Parliament) held parliamentary hearings regarding draft Main Directions for Tax Policy until 2018. The draft, in particular, provides for corporate profit tax benefits for greenfield projects and an increased initial value of depreciated property for tax purposes. It also sets a moratorium on an increased tax burden in Russia until 2018.

On 8 June, the Russian President signed Federal Law No. 150-FZ "On amending Part I and Part II of the Tax Code of the Russian Federation and article 3 of the Federal Law "On amending Part I and Part II of the Tax Code of the Russian Federation (with regard to taxation of profits of controlled foreign companies and income of foreign organisations)".

The Russian Government has adopted a partial moratorium on tax increases and new public payments up until 2019. The moratorium is to be applied to five levies and charges, including the environmental charge aimed at the disposal of waste generated through the consumption of goods. A shortlist of goods (battery, tyre, paper and mercury lamps) has been approved for which a charge of 5-10% of the value will be preserved, while the rest goods will be charged at 0% until 2019.

PRACTICE

The Federal Tax Service has opened a unified Data Processing Centre in the city of Dubna (Moscow Region) to put an end to most VAT and other tax abuses.

The Tax Service has checked the control correlations in electronic VAT returns for Q1 2015. With 1.4 million tax returns being checked, errors were spotted for 46,000 taxpayers. This is the first time that messages to taxpayers regarding the discrepancies identified were generated by the VAT centralised control system ASK-VAT-2 based on the Data Processing Centre and without any tax officers being involved.

The Russian Constitutional Court has admitted a statement from OOO Sony Mobile Communication Rus (a part of the Sony Mobile Communications AB group) regarding the compliance with the law of article 162(1)(4) of the Russian Tax Code, whereby a VAT tax base is increased by insurance payments made under the contracts insuring against the risk of default.

On 4 June, the State Commercial Court for the Moscow Circuit dismissed the cassation appeal of Oriflame Cosmetics. The court came down for the tax authority and concluded that the Russian subsidiary of Oriflame understated its corporate profit tax base by licence payments made to the holding company.
