REGULATORY DEVELOPMENTS

On 3 May, the Russian President signed Federal Law No. 113-FZ. This law establishes that a tax agent is obliged to provide quarterly estimates of personal income tax amounts which it has calculated and withheld, to tax authorities. If it fails to provide such estimates, a penalty is imposed on it and its bank accounts are blocked.

On 6 April, the Russian President signed Federal Law No. 82-FZ. Now companies may stop using a round seal on paper documents.

On 31 March, the Russian President signed a Federal Law aimed at ensuring that the information provided during the state registration of legal entities and individual entrepreneurs is accurate.

On 24 April, the State Duma passed in the first reading the Government's draft law aimed at extending the list of grounds for compensating adjustments of taxes in the case of controlled transactions. The draft law will make it easier for one party to a transaction to adjust profit tax, personal income tax, mineral extraction tax or VAT if the other party states lower amounts of the taxes.

On 10 April, a new version of a draft law has been put before the State Duma. It concerns the general standard for fighting tax abuse. Experts think that the position of taxpayers may deteriorate sharply.

The State Duma is drafting legislative amendments to exempt a number of Islamic banking transactions from VAT.

Russia and China are drafting an agreement setting a zero rate of the tax on interest for companies in both countries.

The Russian Finance Ministry has published a new version of a draft law imposing an obligation on auditors to report to tax authorities. The revised version reduces the volume of information which auditors are to share with tax authorities. Moreover, such information will have to be provided only if a taxpayer itself fails to provide it upon tax authorities' request or if a foreign tax authority requests it.

The Russian President instructed the Russian Government to consider, by 1 July, whether it would be reasonable to introduce 'a mechanism for a resort fee and to direct the relevant income to be used for developing tourism infrastructure'.

The Russian Minister of Communications and Mass Media Nikolay Nikiforov believes it would be reasonable to look into whether foreign Internet companies may be taxed at the location of their customers.

The Russian Ministry of Finance drafted the Main Directions of Tax Policy for the years 2016 through 2018. The plan for the next three years keeps the current structure of the tax system. The main emphasis is placed on changes in administration.

Written clarifications of legislation which are issued by executive authorities can be challenged in court. The Constitutional Court of the Russian Federation handed down such decision on 31 March. The court also imposed an obligation on legislators to set a procedure for appealing against such instruments that lay down official interpretations.

Russian major distributors of electronic appliances have signed a charter concerning transferring to transparent import arrangements. The Russian Federal Tax Service was among those insisting that such agreement should be concluded.
