### Provided legal support for an investment project of a major Korean company

Provided legal support in connection with the implementation of an investment project of a major foreign client in an ASEZ: prepared a report on the possibility of implementing a project in the ASEZ based on Russian legislation, analysed relevant laws and systems for the construction of facilities within the project, and analysed the business structure, such as public-private partnership, in the case of foreign investments.
